### **SUMMARY ANNUAL REPORT**

### For Goodville Mutual Health & Welfare Plan

This is a summary of the annual report of the Goodville Mutual Health & Welfare Plan, EIN 23-0636660, Plan No. 501, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Goodville Mutual Casualty Company has committed itself to pay certain self-insured Medical and Dental claims incurred under the terms of the plan.

## **Insurance Information**

The plan has contracts with Wellspan Employee Assistance Program, Vision Benefits Of America, and United Of Omaha Life Insurance Company to pay Vision, Life Insurance, Longterm Disability, Accidental Death and Dismemberment, and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$118,999.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2024, the premiums paid under such "experience-rated" contracts were \$28,966 and the total of all benefit claims paid under these contracts during the plan year was \$20,327.
