

SUMMARY ANNUAL REPORT

For LIVING BRANCHES WELFARE PLAN

This is a summary of the annual report of the LIVING BRANCHES WELFARE PLAN, EIN 23-2125481, Plan No. 503, for period 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

LIVING BRANCHES has committed itself to pay certain self-insured Medical, Stop Loss, and Short-term Disability claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with PENN FOUNDATION and THE GUARDIAN LIFE INSURANCE COMPANY OF AMERICA to pay Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$303,427.
