

SUMMARY ANNUAL REPORT

This is a summary of the annual report of the GOODVILLE MUTUAL HEALTH & WELFARE PLAN, EIN 23-0636660, Plan No. 501, for period 01/01/2021 through 12/31/2021. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

GOODVILLE MUTUAL CASUALTY COMPANY has committed itself to pay certain self-funded Medical and Vision claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with AMERITAS LIFE INSURANCE CORPORATION, WELLSPAN EMPLOYEE ASSISTANCE PROGRAM, and UNITED OF OMAHA LIFE INSURANCE COMPANY to pay Dental, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$151,459.
